\*Intent is to go over exercise intent PRIOR to briefing the city leadership/meet and greet all lead planners from DOD/LEO's.

\*There is significant change in our "template" since the August 2012 exercise and we are under new DOD regulatory guidance for this type training.

\*I will provide a brief (with hard copy for you to keep) that should be of assistance in dealing with your senior leadership.

18-21<sup>st</sup> – Full mission profiles (ground and Air operations).

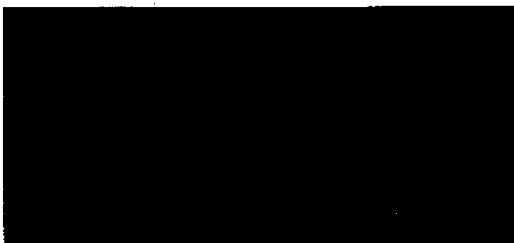
23<sup>rd</sup> – all redeploy.
