Hi Jen – I appreciate your interest in setting an agenda.

I think the most pressing issue will be to review MN's draft Operational Protocol for the adults without children group. We want to make sure we're on the same page with you. We'll submit a draft prior to the call.

In addition, we have a question about allowing certain enrollees to opt out of mandatory managed care to participate in a pilot program for persons with severe chemical dependency who have had multiple inpatient treatment episodes during a certain time period. There are a small number of adults without children who reside in pilot counties and are eligible for a county and state-funded program relating to chemical dependency treatment services. For operational reasons, it is much more feasible to allow such persons to remain in the pilot if they receive their medical services via fee for service rather than managed care. Would Minnesota need an amendment to the PMAP waiver to allow this group to opt into FFS if they qualify for the pilot? We don't believe we need explicit waiver authority to allow this subset of enrollees additional freedom of choice.
