Jessica – thank you for your receptiveness to the State's request to combine the Adults without Children into one MEG for reporting purposes in STCs 46 and 47 in our conversation this morning, as well as your attention to the typographical errors that crept in.

Minnesota has two additional comments. However, we also understand the need to complete the document as soon as possible. While it would be ideal to get these changes taken care of today, none of these items are critical enough to warrant holding up the waiver.

CNOM's

Minnesota believes that separate waiver authority for Income Disregard for Population 9 is unnecessary, since the income levels for population 9 are defined in the Expenditure Authorities. As an analogy, an explicit income disregard waiver hasn't been required for children or parents expansion groups. If CMS finds that this waiver is necessary, Minnesota suggests the following edit:

"To the extent necessary to allow the state to <u>cover apply an income</u> disregard to Population 9 adults without children applicants who have family income above 133 and up to and including 250 percent of the FPL."

STC paragraph 36a

Minnesota suggests the following edit:

American Indian Medicaid recipients, whether residing on or off a reservation, will have direct access to out-of-network services at IHS, 93-638 (IHS/638) facilities, or Urban Indian Organizations. DHS will reimburse IHS and 93-638 providers out-of-network services at a State plan rate, which can be the IHS, FQHC or fee for service rate, depending on provider election except when a 93-638 facility elects to bill as an FQHC. Physicians at IHS and 93-638 facilities will be able to refer recipients to specialists within the MCO network. Enrollees may not be required to see their MCO primary care provider prior to accessing the referral specialist.
