As requested, the attached spreadsheet has been updated to include three years of actual enrollment and cost data for the adults without children groups that are currently covered under our MinnesotaCare program.

Please note that the 133-250% FPG numbers reflect program changes that have occurred during the period. The state-funded program was limited to individuals with incomes at or below 175% FPG until July of 2008. At that time, the income standard was raised to 200% FPL. In July of 2009, the income standard was raised to 250% FPL.
