I. PREFACE

The following are the Special Terms and Conditions (STCs) for Minnesota's Prepaid Medical Assistance Project Plus section 1115(a) Medicaid Demonstration extension (hereinafter "Demonstration"). The parties to this agreement are the Minnesota Department of Human Services (DHS) and the Centers for Medicare & Medicaid Services (CMS). The STCs set forth in detail the nature, character, extent of Federal involvement in the Demonstration, and the State's obligations to CMS during the life of the Demonstration. The STCs are effective August 11, 2008 unless otherwise specified. All previously approved STCs, Waivers, and Expenditure Authorities are superseded by the STCs set forth below. This Demonstration extension is approved through June 30, 2014.
