WHEREAS, the STATE wishes to exercise the option to amend this contract as provided in Article 21;

WHEREAS, a corrected "Appendix I Service Area" is needed for the **Minnesota Senior Health Options (MSHO) and Minnesota Senior Care Plus (MSC+)** contract (Contract);

WHEREAS, the STATE and the MCO have agreed to amend the Contract to include this corrected service area appendix.

Therefore, the parties agree that:

REVISION 1. Appendix I, Service Area is deleted in its entirety and replaced by the attached Appendix I, Service Area Corrected.
