Bill, you asked the other day for an understanding of the various teams that will be working on the Midway redevelopment and the soccer stadium. We've moved quickly this week to get teams assembled and have either had meetings or are in the process of scheduling meetings with you and your colleagues. Below is the roster

Jonathan Sage-Martinson is the Director of Planning and Economic Development. He will lead you through the Community Advisory Committee and master development process. He will be in touch with you shortly to schedule a visioning session for you, the Mayor and Rick since we've never had the three of you in one conversation. We thought it would be good to get on the same page.

Dana Bailey is the Chief of Staff. She directs the work of our Government Relations and Communications teams. We would like to have an initial meeting with you (and if possible Joel) to talk about what resources to bring to the table around government, community and media relations over the next year.

Todd Hurley is our CFO. He is our lead with our attorney Jerry Hendrickson and Kathleen Lamb in working with Sam Kaplan and Ralph Strangis on the development and use agreements.

Louis Jambois at the Port Authority is the lead on the ground lease with Metro Transit. Jonathan and Todd will communicate with Louie based on their work.

I will coordinate Jonathan, Todd, Dana and Louie as we drive towards our goal of beginning construction in summer 2016. I will keep the Mayor apprised of progress as he is watching this project closely.
