"activities -

"Marv Davidoff showed up this afternoon at
VDC office. he is either late 30s or early 40's.
Is Jewish, black hair with receding hair line and
thinning out, about 5'-7", slim build. Has been
very active in the south, esp. Georgia. claims he
was in on Canada to Cuba March, Congress of Un-
Represented Peoples March in Wash. Is here to
give advise on March.

"Bob Herwitt - described in Previous reports -
showed up for the first time at VDC. He is in
charge of parade monitors. He is evidently a high
ranking member of VDC and yet I have never seen
his name on anything. Monitors will have a meet-
ing at 7 PM Thur. Oct 14, Room 11_ Wheeler Hall.

"Young fellow in second photo you withheld -
the tall, young dark haired one is Pete Cohen.

"Helped stuff approx. 1000 envelopes sending
notices to CNVA (Citizens for Non Violent Action).
Noted that Murry Gurko, Eugene Alexander, and
Ernest Cabrillo were members. Ernest lives at
829 43rd San Francisco_ Murry Gurko at 375 Day_
Berkeley.

"During General Membership various reports
were read and meeting with Oakland Parade Permit
Board was discussed. They plan to submit various
alternate proposals to Oakland and Berkeley today,
there Lawyer feels that they would have a better
legal case then if turned down, on which to seek
an injunction. They voted to march irregardless
of a permit or not. This was instigated by a

fellow by first name of Joel who sat next to me. CBS (KPIX) was there with cameras and took shots of Joel. I am looking out from in back with a hot on. Joel conferred with Steve Weissman and then Weissman made move that we march irregardless. Bob Hurwitt & Rubin concurred. Joel is old looking, thin faced, slim, about 5'-7", Jewish, thin hair, & receding hair line, grey rimmed glasses, but probably only around 30. Was a leader in FSM movement as after arrests he went out and organized a steering committee.

"During meeting proposition was agreed upon to elect tomorrow a committee of 9 (& 9 subs in case of arrest) to run VDC after Wens. These people will probably consist of members of the steering committee.

"Jack Wineberg, 5'-8"-9", light brown hair & mustache, close cut and to head, Jewish, sporty dresser. Seems to lead the group along with Jerry Rubin, Steve Weissman, & Joel.

"Tommy Saunder, a DJ, of KYA radio will take advertisement of VDC that was turned down by KYA executives and play in original form anyway. He is in complete sympathy with VDC. He will try and get lots of High School kids to come. Broadcast is evidently from 9-12 and will be done Thursday night. VDC has arranged for many short commercials on air. They are also setting up a booth next to Berkeley High School & other highs in town.
