He is a post-man and a friend of Windy Smith's from Los Angeles. He said he was an ex-Dorothy's Ranger; A nickname for an anti-huac group. Dorothy is Dorothy Healy. Windy Smith told me that Mr. Maitlin Chatlin was used as a spokes man for many groups because he was relatively clean.

"Windy Smith has a bank account in the Sausalito Branch of the Bank of America.

Mr. & Mrs. David Fogarty have just had a phone installed. The number is 655-2147.

"Windy Smith said in regards to Bettina Aptheker Kurzweil's announcement of membership in the CPUSA that the policy for anybody coming out publicly must be a good spokesman, responsible, high-up and very well-known & respected.

"Maitlin Chaitlin (this spelling of the name is approximate) said that his room-mate at UCLA was a member of the Party and that he (no known name) and many others have moved from L.A. to Berkeley.

"A Mr. David Fowler from U.P.I. is very friendly to Windy Smith and very helpful to Smith. Windy told me this in private conversation.

"One further identification on Mr. Chaitlin is that he is studying Karate at the Di-ito (?) School on University between Milvia & Grove. His wife is a student at S.F. State. He was a philosophy major at UCLA.

"The V.D.C. is definitely not arming its monitors with any weapons whatsoever. Violence is to be used as the very last resort to protect life and then only by monitors.

"Mr. Marvin Davidov has quit the V.D.C. because of the voting for violence to be used in the last resort.

"He is probably heading for the Southern part of California.
