But I wanted to ask about something related, but separate.

We were still wondering about our separate state Data Practices Act request to

Hennepin County (dated Dec. 3, 2016) regarding all correspondence for the month of November 2016 involving the sheriff and his staff regarding the North Dakota deployment.

If I recall correctly, Hennepin County had indicated to us that all such information would have to be cleared first by the state DPS.

I'm just circling back to get an update on that request, and to make sure that has not been lost in the shuffle.
