Here is where I understand things are at:

-- We formally asked for internal sheriff's office emails/correspondence for the month of November 2016 regarding Hennepin County's deployment to North Dakota for the pipeline protests. We made the data request in early December 2016.

-- Sometime later, your office responded saying that because the deployment went through the state that the state would have to respond to the request -- including the internal county sheriff's office emails/correspondence.

-- After more months passed, we received the response below in August from the state -- indicating that the internal correspondence/emails would have to come from the county sheriff's office.

As of this point, we do not have any of that correspondence.

The Minnesota Department of Public Safety recently released documentation to us regarding Hennepin County's sending deputies to North Dakota for the Dakota Access Pipeline project. That came following a request we made directly to the state DPS.

But I wanted to ask about something related, but separate.

We were still wondering about our separate state Data Practices Act request to Hennepin County (dated Dec. 3, 2016) regarding all correspondence for the month of November 2016 involving the sheriff and his staff regarding the North Dakota deployment.

If I recall correctly, Hennepin County had indicated to us that all such information would have to be cleared first by the state DPS.

I'm just circling back to get an update on that request, and to make sure that has not been lost in the shuffle.
