one ERIC WEINBERGER, who was introduced as a member of the CNVA. According to the source, WEINBERGER explain the program of the August 6 - 9, 1965, demonstration to be held here in Washington, D.C.

According to the source, WEINBERGER stated that the demonstration will begin on August 6, 1965, with picketing of the White House. During this picketing, six individuals will attempt to climb over the White House fence and gain access to the White House grounds. On August 7, 1965, the CNVA will hold workshops on the Monument grounds. These workshops will be broken down as to subject matter. They will deal in part with the following subjects:

Poverty Welfare Mississippi Freedom Democratic Party

On August 8, 1965, more workshops will be held, but these will be broken down according to professions of the individuals attending, such as students; doctors; lawyers and professors. On August 9, 1965, the CNVA plans a march to the United States Capitol and a walk-in on the House of Representatives. According to WEINBERGER, the CNVA has several hundred passes to the House of Representatives, but rather than going to the Gallery, the demonstrators, when once admitted to the building, will rush to the floor of the House of Representatives and sit-in in any vacant seats. They will also attempt to go to the Rostrum, and if successful in this, the individuals who reach the Rostrum will begin speaking concerning their protest of the United States policy of intervention in Viet-Nam.

WEINBERGER stated that if the demonstrators are denied entrance to the United States Capitol, they will hold a meeting on the steps of the Capitol building and decide future action.

WEINBERGER went on to say that the CNVA has mailed out more than 75,000 flyers advertising the above

demonstrations and that they have a staff of seven paid workers whose job is mostly to locate housing for the individuals participating in the above demonstrations.

According to the source, WEINBERGER stated that they expect more than 6,000 demonstrators and he advised those present that if they could aid in finding housing, or help in any other way, they should call telephone number WOodley 6-7783.

The District of Columbia telephone directory lists WOodley 6-7783 as the telephone number for DONNA ALLEN, 3306 Ross Place, N.W., Washington, D.C.

DONNA ALLEN has been publicly identified as a leader of the Women Strike for Peace, a pacifist organization, and she was convicted in June, 1965, for contempt of Congress, in that she refused to testify before a hearing of the House Committee on Un-American Activities.

On each occasion, the above information concerning the demonstration was furnished by the FBI to the Metropolitan Police Department (MPD), United States Park Police (USPP), United States Secret Service and other local intelligence agencies.

The FBI, through contact with sources from the inception of the proposed demonstration to the dates of the actual occurence, furnished police and local intelligence agencies advance information concerning the identity of participants; organizational set-up; strength of the group; modus operandi and plans for civil disobedience, as well as identity of key figures and organizers. Police and local intelligence agencies, as a result of this advance information furnished by the FBI, were able to adequately plan to have sufficient manpower and coverage of this demonstration in order to preserve law and order.
