Thank you for speaking with us this afternoon. Attached are the revised waiver and expenditure authorities. Please note that we anticipate adding an authority for the farm depreciation, and will follow up on Monday with revised language if that is the case. Also, as we mentioned during our call, we will need to have some further discussion about the children residing in foster care or a juvenile residential correctional facility on the child's 18th birthday before we can determine if additional authorities are necessary.
