Thank you for again contacting the Minnesota Department of Human Services ("DHS"). I received your most recent data request, dated February 22, 2012, on February 24, 2012. In your recent correspondence, you request to inspect the following data.

1. Any and all RFPs issued by your agency during the 2011 calendar year that pertain to contracts for public health care program business related to the pilot program for Hennepin and Ramsey counties established by Minnesota Statutes 256B.0756, or any related legal authority Responsive RFPs should include both technical and cost bid components;
2. Any and all proposals submitted in response to any RFP referenced in Item 1 of this request;
3. Any and all documentation related to the evaluation and scoring of any proposal submitted in response to any RFP referenced in Item 1 of this request;

4. Any and all letters of intent issued by your agency regarding any proposal submitted in response to any RFP referenced in Item 1 of this request;
5. Any and all contracts related to the pilot program referenced in Item 1 of this request;
6. Any and all "rate certification letters" produced by your agency for the calendar years 2011-2012 that relate to rates charged for health care services delivered via capitated state health care programs.

DHS anticipates that some of this data will be available for your viewing on or after March 6, 2012. If you are interested in inspecting the data as it becomes available, rather than comprehensively, you may arrange an appointment for viewing on or after March 6, 2012. If you prefer to inspect the data altogether, I will notify you when it has been wholly collected. Please let me know your preference.

The available data may be inspected between the business hours of 8am to 4:30pm, Monday through Friday at the Elmer L. Anderson Human Services Building (540 Cedar Street; St. Paul, MN 55155). Please contact me to make an appointment.
