When we get documents we write stories on what we have found and publish the documents on our website, publicrecordmedia.org.

Recently, we made a public data request to the University of Minnesota asking if the school had ever attempted to have Bob Dylan house his archives at the school, particularly since Dylan is from Minnesota and had attended the University of Minnesota.

We received some documents from the University of Minnesota, which indicate the

school had made at least one attempt to contact Dylan's representatives in 2011.

I was wanting to know whether the University of Tulsa was aware of any attempts by the University of Minnesota to acquire Dylan's archives.
